



# Conditions of participation and prize conditions for ITech Progress GmbH competitions

For reasons of better readability, the simultaneous use of the language forms male, female and diverse (m/f/d) is dispensed with. All personal designations apply equally to all genders.

## 1. Conditions of participation

Participation in ITech Progress GmbH competitions is free of charge and is subject exclusively to these conditions of participation.

#### 2. Procedure of the competition

The duration of each competition is always expressly stated. During this period, users have the opportunity to participate.

## 3. Participation

In order to take part in the competition, it is necessary to complete and submit an entry form. By submitting the entry form, the participant agrees that their feedback from the entry form may be used for commercial purposes, including publication on the organizer's website and social media platforms. Their full surname and the first letter of their first name may be used. Participants' contributions may be reproduced, published and edited for advertising purposes without restriction in terms of location and time, free of charge and without naming the author.

Participation is only possible within the specified participation period. Entries received after the entry deadline will not be considered in the draw.

Only one submitted registration per participant will be entered into the competition. It is strictly forbidden to use multiple e-mail addresses to increase the chances of winning.

# 4. Eligible participants

Natural persons who are resident in Germany and have reached the age of 14 are eligible to participate. Participation is limited to customers of ITech Progress GmbH.

If a participant has limited legal capacity, the consent of their legal representative is required. Proof of consent must be provided in writing at the time of participation.

All persons involved in the conception and implementation of the competition and employees of the organizer as well as their relatives are not eligible to participate in the competition. ITech Progress GmbH reserves the right to exclude persons from participation at its own discretion if there are justified reasons, for example

- (a) in the event of manipulation in connection with access to or execution of the competition,
- (b) in the event of violations of these conditions of participation,
- (c) in the event of unfair trading or
- (d) in the event of false or misleading information in connection with participation in the competition.

# 5. Winning, notification and transmission of the prize

The winners will be informed of their prize by e-mail. The prize will only be handed over to the winner or the legal representative of the underage winner. It is not possible to exchange, collect or pay out the prize in cash.

ITech Progress GmbH will bear any shipping costs. Any additional costs associated with claiming the prize shall be borne by the winner. The winner is responsible for any taxation of the prize.

If the winner does not respond after two requests within a period of three weeks, the prize may be transferred to another participant.

A prize in the form of a training offer only covers the training fees and does not include examination fees or travel and accommodation costs. This prize is non-transferable and is valid until the specified deadline. If the selected training course does not take place due to insufficient participants, the participant will be rebooked for the next guaranteed training course of the same type. If the winner is unable to attend the rebooked training course, the prize will be forfeited.

Voucher prizes for training courses are non-transferable and are only valid until the specified expiration date. They cannot be combined with other discount campaigns or offers and can only be redeemed once per person and event. If the selected training course does not take place due to a lack of sufficient participants, the participant will be rebooked for the next guaranteed training course of the same type. Cash payment and legal recourse are excluded.

# 6. Termination of the competition

ITech Progress GmbH expressly reserves the right to terminate the competition at any time without prior notice and without giving reasons. This applies in particular to any reasons that would disrupt or prevent the competition from running as planned.

## 7. Data protection

Personal data must be provided in order to take part in the competition. The participant assures that the personal details provided by him/her, in particular first name, surname and e-mail address, are truthful and correct.

ITech Progress GmbH points out that all personal data of the participant will neither be passed on to third parties nor made available for their use without the participant's consent.

In the event of a win, the winner agrees to the publication of their name in the advertising media used by the organizer. This includes the announcement of the winner on the operator's website and its social media platforms.

The participant can revoke his declared consent at any time. The revocation must be sent in writing to <a href="marketing@itech-progress.com">marketing@itech-progress.com</a>.

Once consent has been withdrawn, the participant's personal data collected and stored will be deleted immediately.

# 8. Applicable law

## 9. Severability clause

Should any provision of these conditions of participation be or become invalid in whole or in part, this shall not affect the validity of the remaining provisions. The invalid provision shall be replaced by a legally permissible provision that comes as close as possible to the economic meaning and purpose of the invalid provision. This also applies to any loopholes in these conditions of participation.
